Center Membership

Centers across the country offering equine-assisted activities and therapies can gain access to the support, promotion and education offered through PATH Intl. by becoming a PATH Intl. Member Center.

All centers must have on staff a Certified Therapeutic Riding Instructor (CTRI) have an approved CTRI Application and approval to test letter PRIOR to joining PATH Intl. as a Center Member. For ground based programs, a certified Equine Specialist in Mental Health and Learning (ESMHL) is acceptable. New PATH Intl. Center Members have 12 months from the time their center membership is purchased to acquire a PATH Intl. Certified Instructor if the person is in the process but not fully certified at the time of joining.

After joining PATH Intl. the center is required to follow certain membership requirements (listed below) and adhere to PATH Intl.'s standards for safety and professionalism.

Facts about PATH Intl. Center Membership:

- Center Membership runs January 1st to December 31st. All centers are required to renew their center membership by December 31st each year regardless of their joined date. New center members that join after the first month will pay a pro-rated dues amount for the first year of membership. Renewal dues are not pro-rated after the first year.
- After one year of membership center members are eligible to participate in the accreditation program. Centers are not required to participate upon eligibility. Accreditation fees are not included in the fees shown; they are in addition to center dues.

PATH Intl. Center Membership Requirements:

These requirements apply to all PATH Intl. Member Centers regardless of accreditation status. Failure to follow these membership requirements may result in loss of center membership.

- 1. All PATH Intl. Member Centers must be a member center in good standing.
 - 2. All PATH Intl. Member Centers must have at least 1 instructor who holds a current PATH Intl. Certification meeting the applicable activity standards. (refer to the Activities Standards in the PATH Intl. Standards for Certification & Accreditation manual)
- 3. All PATH Intl. Member Centers must have current insurance coverage in effect at all times that meets or exceeds PATH Intl.'s required limits.
- 4. All PATH Intl. Member Centers must follow all mandatory and applicable standards. All PATH Intl. Member Centers are required to be in compliance with all PATH Intl. Standards that apply to their program activities.
- 5. All PATH Intl. Member centers must have a signed Annual Statement of Compliance form on file with PATH Intl. each year.
