Teaching Hours Tracking to Qualify as a Supervising Instructor for CTRI® Applicants

Using this form:

- This form is for PATH Intl. CTRI credential holders to document the teaching hours required for them to become eligible to supervise CTRI applicants for **part V of the CTRI application**.
- ONLY therapeutic riding lessons should be reported. Both private and group lessons count.
- Hours should be documented starting from the date that the certified professional earned the CTRI credential. (This date is reflected in the month and day of your renewal due date.)
- Lessons do not need to be reported in both hours and minutes. Please select ONE type of duration to utilize throughout the form. (An exception to this can be if a lesson was, for example, one hour and 10 minutes long. In this case, you may choose to report 1 in the hour column and 10 in the minutes column).
- A minimum of 120 hours must be documented. Eligibility to supervise CTRI applicant teaching hours begins the day AFTER your 120th hour is logged.
- Submitting this form will amount to an audit of your teaching hours. Once recorded, you will not be requested to submit documentation of teaching hours as part of randomized audits UNLESS an applicant documents hours for/on dates BEFORE the date of the 120th hour logged on this form.
- PATH Intl. Advanced and Master TRIs with CTRI certification are NOT required to submit 120 teaching hours to be eligible to supervise CTRI applicant teaching hours.

NOTE: a supervising instructor may or may not also be a mentor. Please see page 5 of this document for more explanation.
