# 2022-2023 PATH INTL. BOARD

The officers for the board of trustees continued their tenure for a second term with Ed Milford as president, Jessica Normand as Secretary, and Brandan Montminy as Officer-at-Large. Scott Carver continued as Treasurer and was also elected President-elect. The board also welcomed new trustees Veronica Lac, Christine Sorenson and Marianne Collins.

The board had a very busy year leading PATH Intl. They approved a \$500,000 board designated endowment fund whose proceeds are to be spent on membership benefit(s). They continued their DEI work, facilitated by Point(b) and established a DEI scholarship fund. Four scholarships were awarded for the 2023 PATH Intl. national conference.

The board also established goals for the year including: each trustee furthering their education of EAS, trustees connecting directly with PATH Intl. members at conferences or center visits, and trustees acting as ambassadors by hosting an event or disseminating information.



In addition, the board spent their May retreat setting priorities for the organization. These priorities were based on feedback from the membership. They range from a focus on supporting individuals and centers through the CTRI process, to creating a CTRI Prep workshop, as well as new member onboarding, a focus on social media strategy, and membership retention and reactivation.

# EDUCATION DEPT.

The PATH International Conference was held in St. Louis, Missouri the weekend of October 28-30, 2022. The staff was happy to be back in person with **430 members** and certified professionals registered to join!

There were 5 pre-conferences and 55 concurrent sessions for each person to select from.

The virtual conference was held over three days, April 25, 26 and May 1, 2023. There were three different topics, **Equine Welfare, Disability Education** and a **PATH Intl. CTRI® Preparation Workshop**. On April 25 and 26 there were five, one-hour sessions each day, awarding 10 CEU credits to those who attended. On May 1 we had a collaborative effort to present CTRI prep information and attendees for this day were awarded 5 CEU credits.

In January 2023 PATH Intl. launched an updated member/customer portal in response to member feedback. The updates included a more user-friendly view, searchable items in downloaded education purchased and a single sign on to PATH Intl. Member Connection.

PATH Intl. partnered with the United States Equestrian Federation (USEF) to provide USEF membership for PATH Intl. Professional Plus members to receive access to highly discounted, affordable health insurance. Several months after the launch of this new member benefit, 61 individuals either upgraded their membership or joined as a professional plus member.

Individual and center member numbers remained steady between July 2022 and July 2023.



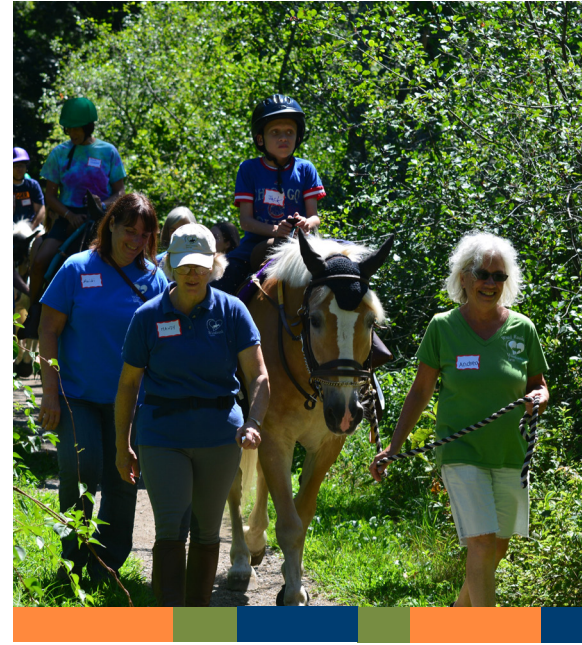
## MEMBERSHIP DEPT. (CONT.)

### ACCREDITATION

Accreditation site visits resumed after the pandemic hold. There were **34 total visits** completed with 28 of those visits completed virtually and six in-person.

### REGION CONFERENCES

There were eight PATH Intl. Region Conferences held that provided education and networking for **665 registrants**. The eight conferences offered a total 95 continuing education hours. The three remaining regions each held state meetings to offer education and networking locally.



### VETERANS PROGRAMMING

#### **Wounded Warrior Project (October 2022 – September 2023)**

102 PATH Intl. Premier Accredited Centers participated in the WWP grant program.

**\$211,690** was distributed for **1,881 sessions**. **762** Wounded Warrior Alumni participated.

The United States Department of Veterans Affairs Adaptive Sports grant began in October 2022 and ran through September 2023. **\$150,845** was distributed for direct services and certification scholarships for Veterans. 25 PATH Intl. Premier Accredited Centers provided direct services to **310 Veterans**. Nine certification scholarships were awarded **\$35,100.00**.

NCCA BY ICE

June 2023 marked a historical achievement for PATH Intl. and EAS when the PATH Intl. CTRI® certification became the first-ever independently accredited credential in EAS and the equine industry. The PATH Intl. CTRI® was granted accreditation from the National Commission for Certifying Agencies (NCCA), the accrediting body of the Institute for Credentialing Excellence (I.C.E.), for a five-year period after demonstrating the program's compliance with NCCA's rigorous Standards for the Accreditation of Certification Programs. With this accomplishment, PATH Intl. joined the prestigious ranks of certifying organizations dedicated to public protection and excellence in certification by enhancing the credibility and legitimacy of their certification programs through demonstrated compliance with stringent standards set by the credentialing community.

PATH Intl. certification programs experienced rebounded growth following the pandemic, as shown above. Most notably, on-site workshops and certification events returned to pre-pandemic levels, including **Two Driving events attended by 9 people, Seven advanced therapeutic riding instructor TRI events attended by 29 people, One interactive Vaulting event attended by 6 people** and **Two new driving instructors were certified.**

# MARKETING & COMMUNICATIONS

Marketing and communications activities for 2022-2023 continued to focus on completion of strategic objectives.

To expand awareness of the organization and equine-assisted services, while consecutively marketing its products and services, PATH Intl. joined with Equine Network in support of their Horse Week and through another partnership gained visibility to natural horsemanship enthusiasts at the Of Horse, Human and Nature Conference featuring Temple Grandin and the Equus Film Festival. The association was also a premier partner in the Seen through Horses Campaign. A trade ad was included in the Equine Affaire program in Massachusetts where region one exhibited on behalf of PATH Intl. The event usually has **60,000+ attendees** during the weekend.

PATH Intl. friends, Zoetis and AAEP mentioned PATH Intl. Member Center H.E.L.P Center of Austin in their social and press releases about their Good Work for Horses award honoring veterinarians. And EAS was a feature with PATH Intl. in the American Paint Horse Association magazine, Chrome.

The most fun and lucrative project the department tackled commenced in 2021-2022 but came to full realization in 2022-2023. The collaboration with Breyer Horse Models on their Hope Horse of the Year

resulted in a beautiful video production and a launch celebration in August reaching tens of thousands at BreyerFest including an appearance by one of the ponies from Central Kentucky Riding for Hope. The limited-edition model horse was designed specifically to celebrate equine-assisted services and PATH Intl. Hope was a pinto Welsh pony with



markings resembling a child hugging her, a heart and the PATH Intl. logo on her belly. The packaging was also specially designed and featured images of participants and horses from the industry. In addition to PATH Intl. receiving a one-dollar donation for every model sold, our hopes were that many families and young

people learning about the industry for the first time would consider EAS as a career path or as a service to explore.

PATH Intl. partnered with an association management company for a short time to research the PATH Intl. membership in order to inform and produce rejoin and retention campaigns. They collected data through surveys and focus groups and considered the member communications preferences we had collected previously in the plan and campaign work they delivered.

The initiative to promote accurate and consistent terminology continued as terminology tools for centers and service providers were created and are found under optimal terminology on the website. The media is also finding these guides helpful.

## Website and Google Ads

Google AdGrants continues to provide approximately **\$10,000** worth of free online ads per month which are used to market the organization to external audiences and drive traffic to the PATH Intl. website.

The website had approximately **610,428 page views** across **242,345 unique viewing sessions** in fiscal year 2022-2023. **564,451** of those pageviews came from the United States, with international views accounting for **7.5%** of website traffic. After the homepage, the therapeutic/adaptive riding certifications page again topped the list of most visited pages with **49,936 page views**. Other pages in the top five were find a center, certification information and the equine specialist in mental health & learning certification pages.

## Email Communications

PATH Intl. continues to use Constant Contact to distribute association communications to its members, credentialed professionals and supporters. In the 2022-2023 fiscal year, **221 email campaigns** resulted in a total of **856,820 sends to contacts**. That volume was **up by 8,560 sends** from the previous year.

The average email open rate is an incredible **52%**, considerably higher than the percentage for other nonprofits and yet another **8% higher** than our own open rate in the previous fiscal year, indicating that members are interested in hearing from their association and staying involved.

## Social Media

Facebook is still the most used social media channel of the association, with **21,843 followers** at the end of this fiscal year, June 2023. As such, there were **304 posts on Facebook** by the association. The post with the most reactions, shares, and greatest reach was unsurprisingly the announcement of the PATH Intl. CTRI® certification receiving NCCA accreditation at the end of this fiscal year. The post reached **12,800 people** and garnered **652 reactions, 64 comments** and **71 shares**. A close second for top post of the year was the announcement of the new equine-assisted learning (EAL) certificate program and EAL fundamentals course, an offering that continues to be very popular.

PATH Intl. also has official Instagram, LinkedIn, Twitter, Pinterest, and YouTube accounts. There were **53 Instagram posts** this year, a **1,700% increase** over the previous fiscal year, resulting in a growth of **108 followers** and a **184% increase** in profile visits. The association's LinkedIn account also saw an increase in engagement, resulting in **321 new followers**, making it the second fastest growing social media account behind Facebook. The analytical information that PATH Intl. social media accounts provide is instrumental in further developing and refining marketing and communications strategies on these platforms to meet the needs of our followers.

Technology guide for service providers needs approval, then will be released. Media is also being given these terminology guides. Considering future outreach tactics to employ once CTRI is accredited.

Breyer continues to market Hope horse.

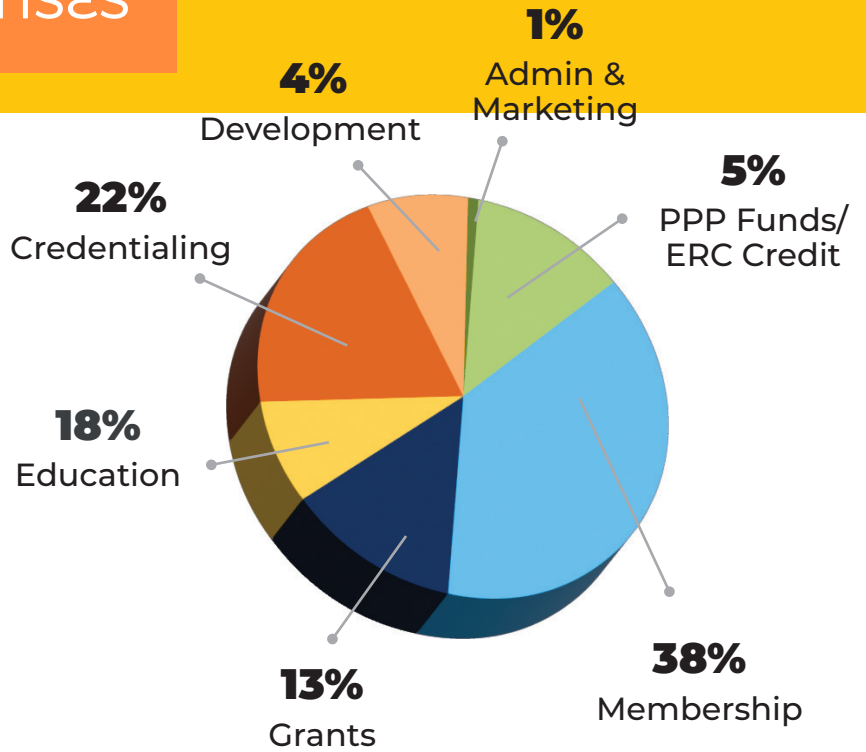

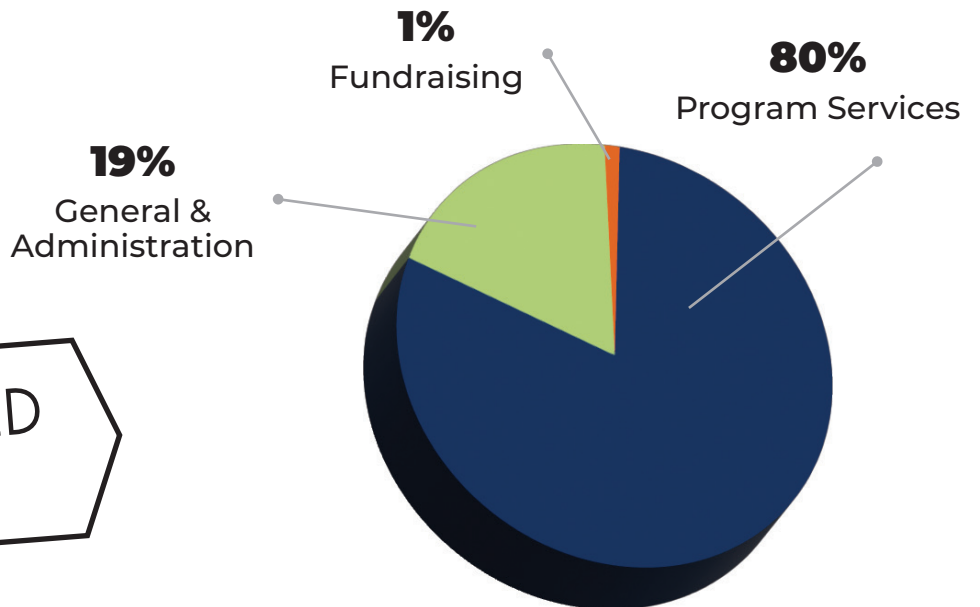
